Subscription Fee Payment

Subscriptions for the 2025-2026 season are £75 per child.

Payment can be made by bank transfer or sum up only. **We do not accept cash.**

Payment by sum up is to be accompanied by a completed registration form and handed to the team coach who will then pass onto the Club Sec & Treasurer.

Payment by Bank Transfer (preferred method) requires using the player's surname and first name or initial and age group for reference such as **U7SMITHJOHN**.
